

MAP SHOWING BOUNDARY SURVEY OF:

(LEGAL DESCRIPTION AS FURNISHED) A PART OF THE HEIRS OF THOMAS FITCH GRANT, SECTION 40, TOWNSHIP 3 SOUTH, RANGE 29 EAST, ST. JOHNS COUNTY, FLORIDA, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS: FOR A POINT OF REFERENCE, COMMENCE AT THE RACIUS POINT OF THE CUL-DE-SAC AT THE NORTHEAST END OF THREE ISLAND COURT, AS RECORDED IN MAP BOOK 33, PAGE 28 AND 29 OF THE PUBLIC RECORDS OF SAID ST. JOHNS COUNTY: THENCE NORTH 52'47'53" WEST, RADIALLY TO SAID CUL-DE-SAC, A DISTANCE OF 52.50 FEET TO A POINT ON THE NORTHWESTERLY RIGHT-OF-WAY LINE OF THREE ISLAND COURT AND THE POINT OF BEGINNING;; THENCE NORTH 37'12'07" EAST, TANGENT TO THE AFOREMENTIONED CURVE, A DISTANCE OF 482.03 FEET; THENCE NORTH 53°05'54" EAST, A DISTANCE OF 200.00 FEET; THENCE NORTH 56°05'51" EAST, A DISTANCE OF 396.52 FEET; THENCE SOUTH 71°29'19" EAST, A DISTANCE OF 312.70 FEET; THENCE SOUTH 21'28'18" EAST, A DISTANCE OF 367.24 FEET; THENCE SOUTH 30'41'31" WEST, A DISTANCE OF 280.00 FEET; THENCE SOUTH 34"13'43" WEST, A DISTANCE OF 333.18 FEET; THENCE NORTH 53"50'52" WEST, A DISTANCE OF 169.51 FEET; THENCE NORTH 32"02'05" EAST, A DISTANCE OF 444.62 FEET; THENCE NORTH 23'42'17" WEST, A DISTANCE OF 155.00 FEET; THENCE SOUTH 89'31'19" WEST, A DISTANCE OF 395.00 FEET; THENCE NORTH 26'19'35" WEST, A DISTANCE OF 99.11 FEET; THENCE SOUTH 68'41'37" WEST, A DISTANCE OF 29.83 FEET; THENCE SOUTH 59°57'59" WEST, A DISTANCE OF 73.22 FEET; THENCE SOUTH 42°24'04" WEST, A DISTANCE OF 56.72 FEET; THENCE SOUTH 52'06'47" WEST, A DISTANCE OF 73.93 FEET; THENCE SOUTH 15'48'11" WEST, A DISTANCE OF 88.39 FEET; THENCE SOUTH 47'44'52" WEST, A DISTANCE OF 73.74 FEET; THENCE SOUTH 39'09'30" WEST, A DISTANCE OF 239.61 FEET TO A POINT ON THE AFOREMENTIONED CUL-DE-SAC; THENCE WESTERLY, ALONG ARC OF SAID CUL-DE-SAC, THE SAME BEING A CURVE CONCAVE SOUTHERLY AND HAVING A RADIUS OF 52.50 FEET AN ARC DISTANCE OF 68.11 FEET, SAID ARC BEING SUBTENDED BY A CHORD BEARING OF SOUTH 74'21'54" WEST AND A CHORD DISTANCE OF 63.43 FEET TO THE POINT OF BEGINNING. ALSO KNOWN AS LOT 3, OF THE ISLANDS OF SWIFT CREEK, RECORDED IN MAP BOOK 33, PAGES 28 AND 29, OF THE PUBLIC RECORDS OF ST. JOHNS COUNTY, FLORIDA. 
